### **1.00 PURPOSE OF REPORT**

**1.01** To enable the Committee to consider setting up a Task & Finish group to consider the feasibility of dog DNA testing in Flintshire.

### **2.00 BACKGROUND**

**2.01** At Flintshire County Council on the 23<sup>rd</sup> of July 2015 Cllr Arnold Woolley submitted the following Notice of Motion:

“That this Council recommends to the Cabinet that they should establish a cross-group working party to examine the process and feasibility of introducing a dog DNA recognition information bank for dog owners within the County, in order to deal effectively with the ongoing most common complaint of ordinary citizens; namely that of the dog faeces fouling of pavements and other locations by that number of irresponsible dog owners who display no social conscience and thereby create a public nuisance and potentially endanger the health and well-being of residents in and visitors to the County”.

Cllr Bernie Attridge, Cabinet Member for Environment suggested that the Environment Overview and Scrutiny Committee be asked to consider setting up a task and finish group to look into the feasibility of introducing a dog DNA registration scheme. Cllr Arnold Wooley welcomed this approach and when put to the vote it was resolved that the Environment Overview & Scrutiny Committee consider setting up a task and finish group and report the findings back to Cabinet for consideration.

### **3.00 CONSIDERATIONS**

If established, a draft project plan will be submitted to the first meeting of the Task & Finish group.

Possible enquiry areas include:-

- the outcome of pilot schemes introduced in England
- the financial implications
- the potential savings in terms of the cost and resources required to remove dog faeces and enforcement action

A recent report by the Association for Public Service Excellence (APSE) 'Park Life, Street Life: Managing demand in the public realm' urges councils to adopt innovative approaches to keep their areas 'clean and green'.
