A mid-term review had been agreed (no later than 15 years into the operational life of the contract) to consider:

- The operational life of the contract (whether to exercise the option to extend the contract with WTI by up to 5 years as stipulated in the Project Agreement);
- Options beyond the WTI contract (e.g. do the Authorities want to remain in partnership and re-procure a new contract for the operation of the facility after WTI's contract);
- How to manage and distribute any residual value of the buildings and equipment related to the operation of the facility upon closure of the contract. For the avoidance of doubt, the residual value refers to the physical building(s) and other assets only, not the site itself (which is dealt with elsewhere within the IAA2).

#### **RESOLVED** that members:

- Following finalisation by the Lead Chief Executive, Partner Authorities sign the 2<sup>nd</sup> Inter Authority Agreement.

- iv) Subject to satisfactory conclusion of the issue listed in recommendations ii) and iii) above, give delegated authority for the Lead Chief Executive to sign the Agreement on behalf of the Lead Authority in the presence of the Chair or Vice-Chair of the Joint Committee.

**RESOLVED** that the updated Risk Register for the project be noted.

## 7.2 COMMUNICATIONS UPDATE (REPORT)

The Project Manager updated members on communication matters concerning the North Wales Residual Waste Treatment Project (NWRWTP). A pack containing copies of the press and media coverage since January 2014 had been made available to members.

#### 7.3 STATEMENT OF ACCOUNTS

Gary Ferguson, Section 151 Officer (Flintshire County Council) presented to members the Statement of Accounts 2013/14 for the North Wales Residual Waste Treatment Project (NWRWTP) incorporating those changes agreed with the Wales Audit Office (WAO) during the course of the audit.

Under the International Standards on Auditing (ISA) 260, the WAO were required to communicate relevant matters relating to the audit of the final statements to those charged with governance, which for the Partnership was the Joint Committee.

Ron Parker, WAO, informed members of the key points within the Audit of Financial Statements Report.

#### **RESOLVED** that members:

- Approve the final version of the Statement of Accounts 2013/14 (subject to the public inspection period as noted within the WAO report)
- Considered and approve the WAO's report; Audit of the Financial Statements North Wales Residual Treatment Partnership
- Approve the Letter of Representation (subject to the public inspection period as noted within the WAO report).

## 7.4 ANNUAL GOVERNANCE STATEMENT

David Webster, Internal Audit Manager (Flintshire County Council), presented to members the Annual Governance Statement.

For each financial year, the Project were required to produce an Annual Governance Statement (AGS) as part of its final accounts. This statement explained the governance framework in operation throughout the year and how it had been reviewed to ensure it was effective

The AGS has been prepared to comply with "Delivering Good Governance in Local Government: A Framework" published jointly by CIPFA and SOLACE. It had then been submitted to the Chief Executive, Section 151 Officer and Monitoring Officer of the Lead Council for their observations. It had been considered by the Project Board on 13 June 2014. The final version, following approval by the Joint Committee, would be submitted to the Chief Executive of the Lead Council and the Chair of the Joint Committee for signing.

The AGS had also been considered and approved by the Wales Audit Office.

**RESOLVED** that members considered and approve the Annual Governance Statement for signing.

# 8. PROGRESS

#### 8.1 2<sup>ND</sup> INTER AUTHORITY AGREEMENT

The Project Manager presented the 2<sup>nd</sup> Inter Authority Agreement (IAA2) Report to update members on progress and to allow for discussion to finalise the Agreement.

The IAA2 had been the subject of detailed feedback from the legal, technical and financial officers, as well as the Project Board and was at a stage that required finalising and signing by the Partner Authorities.

A mid-term review had been agreed (no later than 15 years into the operational life of the contract) to consider:

- The operational life of the contract (whether to exercise the option to extend the contract with WTI by up to 5 years as stipulated in the Project Agreement);
- Options beyond the WTI contract (e.g. do the Authorities want to remain in partnership and re-procure a new contract for the operation of the facility after WTI's contract);
- How to manage and distribute any residual value of the buildings and equipment related to the operation of the facility upon closure of the contract. For the avoidance of doubt, the residual value refers to the physical building(s) and other assets only, not the site itself (which is dealt with elsewhere within the IAA2).

#### **RESOLVED** that members:

- Note the report and its contents
- Following finalisation by the Lead Chief Executive, Partner Authorities sign the 2<sup>nd</sup> Inter Authority Agreement.

# 8.2 FINAL BUSINESS CASE (VERBAL REPORT)

Colin Everett, Chief Executive, (Flintshire County Council) presented a verbal report to members regarding the Final Business Case.

The Final Business Case would be presented to Ministers on the 6 August 2014. Following approval by the Welsh Government, the Final Business Case would then be in the public domain.

At this juncture, members expressed their gratitude to the Flintshire Officers for their hard work and smooth running of the Project.

**RESOLVED** that the verbal report be noted.

#### 8.3 PROCUREMENT UPDATE AND FINANCIAL CLOSE WITH WTI

The Project Manager presented the Procurement Update Report to update members on the progress of discussions with Wheelabrator Technologies Inc (WTI) to reach financial close.

Whilst discussions with WTI were now almost complete, there remained a significant amount of detailed work to be completed. It had been clear that reaching Financial Close would move beyond July, however, the intention remained to work through August to resolve the remaining issues and close off the details and reach Financial Close by the end of August.

# **RESOLVED** that the Joint Committee:

- i) Note the content of the report
- ii) Give delegated authority to the Lead Chief Executive to conclude discussions with WTI to resolve the remaining matters:
  - (a) Reach agreement on the Intervention Event final wording
  - (b) Reach a position that is acceptable to the Partnership, WTI and Welsh Government on the Property issues, specifically the Restricted Covenant.
- iii) To give delegated authority to the Project Board to choose the option for dealing with Foreign Exchange based on advice from the Finance Offices and the project's financial advisors, Grant Thornton, subject to the option chosen being a "no worse" position than that outlined at CFT.
- iv) Subject to satisfactory conclusion of the issue listed in recommendations ii) and iii) above, give delegated authority for the Lead Chief Executive to sign the Agreement on behalf of the Lead Authority in the presence of the Chair or Vice-Chair of the Joint Committee.

#### 9. ANY OTHER BUSINESS

Colin Everett, Chief Executive, (Flintshire County Council) confirmed that Wheelabrator Technologies Inc. (WTI) had recently been sold by its parent company. The takeover posed no risk but the Legal and Financial Officers were to carry out further extensive checks to clarify the position. The takeover of WTI would be added to the Risk Register for reference.
