#### 15. DECLARATIONS OF INTEREST

Councillor Ian Smith declared a personal interest in agenda item 4 – School Transport Commissioning and Operating, due to the close association of a family member.

Councillor Tudor Jones declared a personal interest in agenda item 8 – School Organisation, as a local Ward Member for a school mentioned within the report.

Councillor Patrick Heesom also declared a personal interest in agenda item 8 – School Organisation, as a Member who attended school governor meetings.

Mr. David Hytch declared a personal interest in agenda item 8, as Chair of Governors of the federated school mentioned in the report.

#### 16. MINUTES

The minutes of the meeting of the Committee held on 28 July 2017 had been circulated to Members with the agenda.

#### **RESOLVED:**

That the minutes be approved as a correct record and signed by the Chairman.

#### 17. SCHOOL TRANSPORT COMMISSIONING AND OPERATIONS UPDATE

The Chief Executive referred to the supporting paper which had been distributed at the meeting to provide an update on the re-procurement of transportation routes by the Integrated Transport Unit (ITU). He advised that the purpose of the paper was to explain recent events and operational challenges during the transition to the new transportation routes and operators, to provide assurance that the services had returned to normal, and to consider how to improve arrangements for the future.

The Chief Officer (Streetscene and Transportation) explained that the Council had faced a unique set of circumstances due to a move to a new method of procurement, the retendering of all routes as a single exercise, and managing the transition during the schools Summer recess. He reported on the transition to new transportation routes and operators, the challenges experienced, and the key improvements for the future. In conclusion the Chief Officer gave an assurance that there had been no risk to pupils and school transport provision had been maintained throughout the transition process.

Councillor Aaron Shotton commented on the need for review and rationalisation of school transportation provision and said a number of anomalies within the existing operating arrangements had been identified. The review had resulted in a number of improvements which would minimise risk and maximise quality of service provision for the future.

#### RESOLVED:

That the update report be noted.

#### 18. FINANCIAL FORECAST AND STAGE ONE OF THE BUDGET 2018/19

The Chief Executive introduced the report on the current financial forecast position for 2018/19 and on the Stage 1 Council Fund Revenue budget proposals for 2018/19. He provided background information and context and advised that the emergent options for the Education and Youth portfolio, the financial pressures, and the timeline for the budget setting process were set out within the report. The Chief Executive also referred to the Education and Youth Operating Model and Resilience Statement which

were appended to the report. He advised that the Provisional Local Government Settlement for Wales was due to be announced on 10 October.

The Corporate Finance Manager reported on the financial forecast and the national, local, inflation and workforce pressures, as detailed in the report specific to the Education and Youth portfolio. The Finance Manager reported on the current pressures in relation to Schools Budget.

In response to a comment by Councillor Patrick Heesom concerning Youth Service provision the Chief Executive gave an assurance that the provision in the base budget, as it stands, would be retained.

Lynn Bartlett expressed concerns on the impact of reducing nursery education and commented on the long term value of education in the early years.

#### **RESOLVED:**

That the Committee is satisfied with the approach being taken to Stage One of the Budget within the Education portfolio.

#### 19. REVISED REGIONAL MODEL FOR SECONDARY SCHOOL SUPPORT

The Chief Executive introduced a report to provide an overview of the new arrangements within the Regional School Improvement Service to give greater support to secondary schools, that came into effect in September 2017.

The Interim Senior Manager School Improvement Systems explained that a recent review of school performance by GwE highlighted concerns about secondary school performance across the North Wales region. The review also concluded that the original operating model of an 80/20 split of resources in favour of primary schools was no longer fit for purpose and that more resources needed to be directed towards secondary schools to secure rapid improvement. She introduced Mr Alwyn Lloyd Jones – Assistant Director for GwE, Mr Elfyn Vaughan Jones – Regional Secondary Lead for GwE, and Mr Martyn Froggett – Secondary Core Lead for Flintshire, and invited them to report on the rationale for change and provide an overview of how the revised regional model for secondary school support would be implemented.

Councillor Dave Mackie commented on secondary school performance in Flintshire and provided information on the percentage of students achieving level 2 plus from 2013 and 2016 in secondary schools as an example of his concerns. In responding to the issues raised, officers from GwE acknowledged the need for improvement and said progress was being made. GwE officers also gave an assurance that Flintshire secondary schools were performing well in comparison to other authorities.

During discussion officers responded to the further comments and concerns raised around the data provided in the report concerning the performance of schools based on free school meals benchmarks and eligibility.

Mr. David Hytch raised the issue of teacher recruitment and commented on the problem of recruitment of teachers in specialist subjects, citing Maths as an example. Councillor lan Roberts concurred with the comments made by Mr. Hytch on the issue of the recruitment and retention of teachers in Flintshire schools and suggested that the Committee may wish to send a further letter to the Welsh Government Cabinet Secretary for Education to outline its concerns and this was agreed by the Committee. It was also agreed that the Facilitator would circulate a copy of the previous letter which had been sent to the Welsh Government Cabinet Secretary for Education and the Minister's response.

During discussion the further issues of support for headteachers, the health and wellbeing of school staff, work-life balance, and sustainable leadership programmes, were raised.

#### **RESOLVED:**

- (a) That the Committee supports the changes to the regional support model for secondary school support;
- (b) That the Committee acknowledges the enhanced support for secondary schools and the changes designed to improve school performance in Flintshire; and
- (c) That the Facilitator writes to the Welsh Government Cabinet Secretary for Education, on behalf of the Committee, outlining its concerns around teacher recruitment.

#### 20. LEARNER OUTCOMES 2017

The Interim Senior Manager School Improvement Systems presented a report to inform the Committee of the validated learner outcomes for Foundation Phase, Key Stage 2 and Key Stage 3, and to share the provisional learner outcomes at Key Stage 4 and 5. She advised that the report also compared Flintshire's performance to other Councils in the North Wales region and across Wales as a whole.

The Interim Senior Manager provided background information and explained that attached to the report were individual annexes which provided detailed analysis of the performance of each key stage for 2017 including comparisons to the previous year and to the current Welsh averages. The Committee were asked to note the attainment of Flintshire children and young people for the 2016-17 in Foundation Phase, Key Stage 2 and Key Stage 3 and the provisional data for Key Stages 4 and 5.

Councillor Ian Roberts paid tribute to the hard work of schools in achieving good and improved performance, above expected levels, in all indicators in the Foundation Phase and Key Stages 2 and 3. Flintshire's provisional performance at Key Stages 4 and 5 was also noted, He suggested that the Committee may wish to express its congratulations and thanks to schools for their hard work and achievements.

During discussion the Interim Senior Manager responded to the comments made around the difference in attainment in Welsh between boys and girls, and the change in ranking for Information Technology in 2017.

#### **RESOLVED**

- (a) That the Committee notes the attainment of Flintshire children and young people for the year 2016-17 in Foundation Phase, Key Stage 2 and Key Stage 3, and the provisional data for Key Stage 4 and Key Stage 5; and
- (b) That the Committee receive the validated attainment figures for Key Stage 4 and Key Stage 5 at a future meeting.

#### 21. SCHOOL ORGANISATION

The Senior Manager, School Planning and Provision, introduced a report to provide an update on Federation and other school organisation proposals.

The Senior Manager provided background information and context and referred to the key considerations, as detailed in the report, concerning the capital improvement project at Connah's Quay High School, which also encompassed works to demolish parts of the former John Summers High School building, and the proposed scheme at Penyffordd to amalgamate the current split-site arrangement and bring all primary provision onto one site.

During discussion the Senior Manager responded to the comments and concerns raised around Federations and school organisation. He advised that an update on Federation school organisation issues, both nationally and locally, was appended to the report.

#### RESOLVED

That the progress of the School Modernisation Programme be noted.

#### 22. FORWARD WORK PROGRAMME

The Education & Youth Overview & Scrutiny Facilitator presented the current Forward Work Programme for consideration.

During discussion Councillor Ian Roberts advised that the Welsh Government had halted proposed changes to the Curriculum and therefore the Curriculum Reform item scheduled for the 23 November meeting should be removed from the forward work programme for the time being.

#### **EXECUTIVE SUMMARY**

This report provides an update on the free Childcare offer and seeks agreement from members to extend the offer to other areas of Flintshire.

The aim of the 30 Hour Childcare Offer is to mitigate against the effects of poverty on outcomes for children and reduce inequalities. The provision of high-quality early education and childcare is central to the Welsh Government's 'Building a Brighter Future', the 10 Year Plan which sets out the Government's commitment to improve the life chances and outcomes of all children in Wales.

In the autumn of 2016 the Cabinet Secretary for Communities and Children sought bids from all 22 Local Authorities to become early adopters of a pilot funded child care scheme. Flintshire's bid to become an early implementer and to pilot the scheme was successful and was selected as one of seven authorities across Wales.

The offer is currently being piloted in three specific areas within Flintshire. We are working with Welsh Government to develop local models for the further full national roll out of the funded childcare offer.

The Childcare Offer undertakes, by the end of the current Welsh Assembly in 2021 to provide working parents with 30 hours of government-funded childcare and early education for 3 and 4 year olds for 48 weeks of the year. This includes 9 weeks of up to 30 hours funded childcare within the school holiday period, with the aim of supporting families with quality, flexible and affordable care. It will also support economic regeneration and reduce pressures on family income and help parents to participate in work reducing a family's risk of poverty.

The Offer also supports the wellbeing of children through positive and rich childhood experiences.

The development and delivery of the Offer is a joint partnership between Early Years

and Family Support (Social Services) and Early Entitlement (Education and Youth).

The first children took up the offer on 4 September 2017, with 215 applications having been received. Flintshire have been successful in automating the application process enabling parents to register on line and self-select registered childcare providers from the registered 134 providers.

The original figure of 441 children will be increased to 748 children, is subject for approval by cabinet.

#### **RECOMMENDATIONS**

Members to consider the progress made with the implementation of the Childcare offer and the proposed extension of the pilot to all areas within Flintshire.

#### REPORT DETAIL

1.00	THE CHILDCARE OFFER FOR WALES
1.01	The Childcare offer will, by the end of the current Welsh Assembly in 2021, aim to provide working parents with 30 hours of government-funded childcare and early education for 3 and 4 year olds for 48 weeks of the year. This includes 9 weeks within the school holiday periods.
1.02	The funded childcare offer will combine the successful Foundation Phase (Early Entitlement) provision during term times with additional childcare. During the weeks of the year when Early Entitlement is not provided, qualifying children can receive up to 30 hours of childcare, supporting working families with the costs of holiday care.
	Example:  Child's date of birth: 21 December 2014 – they will be 3 on 21 December 2017. This entitles the child to attend Foundation Phase education for a minimum of 10 hours per week, from the term after their 3 <sup>rd</sup> birthday (January 2018 – July 2018).
	Providing the child's parent is a 'working parent' and satisfies the eligibility criteria the child can also receive up to a further 20 hours childcare during the term time, making a total of 30hrs. This may be at the same childcare setting or an alternative arrangement with up to 3 registered childcare settings. Settings have to be registered with the Care and Social Services Inspectorate Wales (CSSIW).
1.03	The Welsh Government want the offer to be as clear and easy to access as possible, for parents and childcare providers. Flintshire has developed a simple electronic application form, similar to the school admissions process. The form automatically checks whether parents meet the eligibility criteria and whether they live in one of the pilot areas.
1.04	The scheme allows parents to choose the provider that best suit their

	circumstances subject to availability of places. Since May 2017, there have been several workshops with providers and childcare organisations to inform them of the offer and how it will be developed in Flintshire.
1.05	The Welsh Government are monitoring the availability and accessibility of childcare in different parts of Wales and seeing if it matches what parents need. They will reviewing the nature of childcare issues and barriers facing parents and providers and what can be done to overcome them. One of the issues that Flintshire has identified it will test through the pilot is working with Cheshire concerning cross-border take up.
1.06	The first year of the Offer is a pilot and will seek to test and learn from:
	<ul> <li>How accessible and easy it is for parents to access the offer;</li> <li>How accessible and easy it is for providers to provide the offer;</li> <li>How the offer fits alongside Flying Start and the Early Years Foundation Phase (Early Entitlement).</li> </ul>
1.07	The pilot will also provide an opportunity to identify any issues that may surface for parents, local authorities and childcare settings as a result of providing and testing the offer and how these issues can be addressed.
1.08	In March the Cabinet Secretary published a statement on the offer detailing the eligible areas to be included in the Flintshire pilot and the rationale supporting the selection of the areas:
	Flintshire initially tested the Childcare Offer in the three areas at Bagillt, Broughton and Buckley. Approval for a rollout across Flintshire will see maximisation of the grant and provide support for up to 748 children.
	Extending the Offer will test the areas of low and high employment, across travel to work routes, including travel outside Wales and through a mixture of maintained and non-maintained settings.
	The Offer will test the capacity and demand of childcare with how it fits with the Foundation Phase (Early Entitlement) and Welsh medium provision.
	Testing the Offer more widely will allow the Welsh Government to make sure they learn what works and what doesn't in the delivery of the Offer, in readiness for the rollout across the whole of Wales during the lifetime of this Assembly.
1.09	Initially it was estimated that 441 children could be eligible to access the Offer. However, by extending the offer and depending upon take up it may be possible to offer places for up to 748 children for the financial year to 31 March 2018. Work continues with Welsh Government to anticipate and monitor demand and take up.
1.10	It is important to ascertain that there are enough providers and settings for 748 children, so a detailed piece of work is taking place in relation to the Childcare Sufficiency Assessment and working with settings to register as a new provider or update an existing CSSIW registration to accommodate 3 and 4 year olds, for childcare.
1.11	A Grant Offer letter was issued to the Authority to provide funding for a Page 11

	planning stage covering the period December 2016 – March 2017. Further grant letters have been received for the term 1 April 2017 to 31 March 2018 for administration; childcare; and Special Educational Needs.
1.12	A comprehensive project plan was developed which continues to be followed, reviewed and updated as the Offer in Flintshire evolves. Regular meetings with Welsh Government officials have helped shape the Offer and ensure that it meets the project objectives. All key milestones set by WG have been achieved ahead of schedule by the Flintshire team.
1.14	In consultation with the Early Implementer Local Authorities, the Welsh Government has developed and continues to update a core script which governs the development of the offer locally. The core script has also been used to develop a series of comprehensive Frequently Asked Questions (FAQ) from the perspective of the childcare provider and the parent. This script and the FAQ continue to evolve as the offer develops.
1.15	In June the Deputy Director for Childcare, Play and Early Years Division of the Welsh Government, indicated that the budget for the offer is in place for the next two years in the first instance. In September, the Deputy Director visited Flintshire to discuss the development of the Offer.
1.16	In June the Cabinet Secretary published a statement on the offer, announcing the rate childcare providers would be paid at £4.50 per hour per child. This rate covers childcare only and does not include food, drink, off-site activities that incur an additional cost or transport. Providers will be able to charge an additional fee for these services if necessary. However, providers will not be allowed to charge more than £7.50 per day for any food and drinks provided.
	Parents paying for additional hours over the 30 hours available through the Offer and for food, transport and activities will also be able to use the Tax Free Childcare Scheme to help meet these costs.
	The scheme in Wales is not to be confused with the scheme in England which is different.
1.17	Periodically, during the time parents receive the offer, they will be required to reconfirm their eligibility for the offer. Parent eligibility checks will be carried out as follows:
	100% of parents will be asked to provide evidence of eligibility when making an application for the first time.
	100% of parents receiving the offer will be asked to re-confirm eligibility via a tick box at the beginning of each term.
	20% of parents receiving the offer will be asked to provide evidence of eligibility within each term.
1.18	As the £4.50 childcare rate provided by Welsh Government is higher than the rate received by providers of Early Entitlement Education from Councils, a risk has been identified that parents may be encouraged to take the full childcare hours and not take up their early education hours. 2.01	There are no immediate financial implications for Flintshire County Council resulting from the 'the Offer' this is a fully grant funded programme by the Welsh Government. The grant is administered by the local authority as the accountable body.  Should in the future Welsh Government decide to end the scheme there may be some redundancy costs.
2.02	The Welsh Government has provided a budget for the administration of the offer locally for 2016/17 and 2017/18. This is a separate grant to the payments to settings.

3.00	CONSULTATIONS REQUIRED / CARRIED OUT
3.01	Locally, the Childcare Sufficiency Assessment has been undertaken as well as a provider event which was held on the 4 May 2017 and 13 September. Further consultations will be conducted as the offer develops.
3.02	A detailed consultation exercise called <b>#talkchildcare</b> was undertaken nationally by the Welsh Government. Engagement through the consultation resulted in 3768 responses from parents online; 180 queries and comments; 2000 parents spoken to at roadshows; 262 providers involved; 64 parents participated in focus groups; 6250 responses in total. Initial findings of the consultation have been published by the Welsh Government.

# Early Implementation of the Childcare Offer Q&A's for providers



What is the childcare offer? The new childcare offer will provide working parents with 30 hours of early education and childcare for 3 and 4 year olds, for up to 48 weeks per year. The offer will build on children's existing early education entitlement during term time, and provide 30 hours of childcare for 9 weeks of the holidays.

What does it mean for me as a provider? Providing you are registered with CSSIW (or the equivalent in England), you could receive funding from a pilot local authority for eligible 3 and 4 year olds accessing the offer in your setting.

Where are the pilot areas? There are pilot areas in Anglesey, Blaenau Gwent, Caerphilly, Flintshire, Gwynedd, Rhondda Cynon Taf and Swansea. More information on specific areas is available on the local authority websites.

**Do I need to be based in a pilot area to be involved in the early implementation of the offer?** No. Parents need to be eligible and live in a pilot area to access the offer. However the childcare element of the offer can be delivered by any registered childcare setting, regardless of location.

**Do I need to deliver the Foundation Phase to deliver the childcare element of the offer?** No. Some children will continue to access early education in maintained settings. Childcare providers do not need to deliver both the early education and childcare elements of the offer.


**Do I need to be able to deliver the offer for 48 weeks per year to take part?** No. Parents can access the offer through different providers that best suit their circumstance. Providers who only offer term-time provision, or provision only the in school holidays can still deliver the offer.

**How much will I get paid?** All providers will receive a rate of £4.50 per hour for children receiving the childcare element of the offer.

Can I charge parents a top-up rate? No. You cannot charge hourly top-up rates if you'd normally charge more than £4.50 per hour.

Can I charge for food and additional activities? Yes. If necessary, you can charge parents for additional elements such as food, transport and off-site activities which incur a cost. The Welsh Government guidelines in respect of setting additional fees under the offer for a full day care session (approximately 10 hours) are that parents should not be charged more than £7.50 per day (this would include three meals at £2 per meal and 2 snacks at a charge of 75p per snack). For a half day session (approximately 5.5 hours) parents should not be charged more than £4.75 (two meals at £2 per meal plus a snack at a charge of 75p per snack). For sessional care where a meal is not provided but children receive a snack, guidelines are that parents should not be charged more than 75p per day for snack provision.

**How will I get paid?** You should claim funding for the hours a child has registered with you under the offer from your local authority

Beth yw addysg gynnar? Mae hawl gan blentyn i gael addysg gynnar (Meithrin Cyfnod Sylfaen) o'r tymor ar ôl ei ben-blwydd yn 3 oed. Mae pob awdurdod lleol yn darparu isafswm o 10 awr o addysg gynnar yr wythnos, naill yn yr ysgol leol neu mewn lleoliad tebyg, fel lleoliad gofal dydd neu ganolfan gymunedol. Yn ystod y tymor ysgol, bydd yr addysg gynnar yma yn rhan o 30 awr y cynnig gofal plant. Yn ystod gwyliau ysgol, pan nad oes addysg gynnar, bydd y cynnig yn rhoi 30 awr o ofal plant am gyfnod o hyd at 9 wythnos. Gall eich Gwasanaeth Gwybodaeth i Deuluoedd lleol eich helpu i ddarganfod darpariaeth cofrestredig sy'n ateb eich gofynion.

Pa ardaloedd yw'r ardaloedd peilot? Maent mewn ardaloedd dynodedig o Abertawe, Caerffili, Gwynedd, Rhondda Cynon Taf, Sir y Fflint ac Ynys Môn. Bydd y cynllun ar gael ar draws Blaenau Gwent. Mae rhagor o wybodaeth am yr ardaloedd hyn i'w gweld ar wefannau'r awdurdodau lleol. Mae angen ardaloedd peilot arnom er mwyn profi'r cynnig i wneud yn siŵr ei fod yn gweithio, ond bydd ar gael ledled Cymru yn y pen draw.

Gai ddewis unrhyw ddarparwr gofal plant? Gallwch, ar yr amod bod y darparwr hwnnw yn hapus i fod yn rhan o'r cynnig a'i fod wedi ei gofrestru ag AGGCC neu â'r Swyddfa Safonau mewn Addysg (yr arolygiaethau ar gyfer lleoliadau gofal plant). ### **The Childcare Offer for Wales**



#### FAQ's for parents in pilot areas

What is the childcare offer? The childcare offer will provide eligible working parents with 30 hours of a combination of early education and childcare for 3 and 4 year olds, for up to 48 weeks per year.

What does it mean for me as a parent? If you have a 3 or 4 year old you could access your early education entitlement now. If you're working, you could receive additional hours of government-funded childcare on top, so that you receive a combined total of 30 hours of childcare and early education per week for up to 48 weeks a year, depending on when your child has their birthday.

What is early education? Children are entitled to early education (Foundation Phase Nursery) from the term after their 3<sup>rd</sup> birthday. All local authorities provide a minimum of 10 hours per week early education, either in the local school or in a setting like a day-care setting or a community centre. During term time, this early education will be part of the childcare offer's 30 hours. During the school holidays, when there is no early education, the offer will provide 30 hours a week of childcare, for up to 9 weeks. Your local Family Information Service will be able to help you find a registered provider that offers the service that meets your needs.

How will I know if I'm eligible? All parents of 3 and 4 year olds can already access the early education entitlement. You are eligible to receive the additional childcare if you live within a pilot areas, have a child within the age range and earn on average a weekly minimum equivalent of 16 hours at national minimum wage (NMW) or national living wage (NLW) or more. If you are in a lone parent family you need to be working and if you are in a two parent family you both need to be working. If you are self-employed or on a zero hours contract you need to be able to prove this by providing the relevant documents. You can contact your Family Information Service for more information.

Where are the pilot areas? They are in specific areas of Anglesey, Caerphilly, Flintshire, Gwynedd, Rhondda Cynon Taf and Swansea. It will be available in all of Blaenau Gwent. More information on these areas is available on the local authority websites. We need pilots to test the offer to make sure it works, but it will eventually be available across Wales.

Can I choose any childcare provider? Yes, as long as they are willing to be part of the offer and they are registered with CSSIW or OFSTED (the inspectorates for childcare settings). They can do this by getting in touch with your local Family Information Service. Childcare providers can be outside of your pilot area, your county or even in England if you live on the border. There is no restriction on when you can use the additional childcare hours of the offer but it is up to you to find a childcare provider that suits your families' needs. The Family Information Service can help you by providing information on all the childcare settings.

Will I have to pay for anything? The Childcare Offer funds a maximum and total of 30 hours of early education and childcare. This is for the education and care the professionals within the setting provides. It does not include food, transport to and from other settings or off-site activities that incur an extra charge and providers will be able to charge you for these. The cost of transport will depend on where you live and how far they have to travel. Providers should not charge more than £7.50 per day for food or £4.75 for half a day (including lunch).

**Do I have to use all 30 hours per week?** No. You can chose how much of the 30 hours you use. However, if you do not use all of yours 30 hours in one week, you can not use them in another week. You can pay for additional hours yourself based on a private contract between you and your childcare provider.

**How do I apply?** You can apply for the offer, including your early education entitlement place, through your local authority. Contact your local Family Information Service for more information.



#### What is the childcare offer?

The childcare offer will provide eligible working parents with 30 hours of a combination of early education and childcare for 3 and 4 year olds, for up to 48 weeks per year.

# What does it mean for a parent?

A 3 or 4 year old could access early education entitlement. If the parent is working 16 hours or more, they could receive additional hours of government-funded childcare on top, so that they receive a combined total of 30 hours of childcare and early education per week for up to 48 weeks a year, depending on the child's birthday.





#### What is early education?

Children are entitled to early education (Early Entitlement) from the term after their 3<sup>rd</sup> birthday and (Foundation Phase Nursery) September after their 3<sup>rd</sup> birthday.

All local authorities provide a minimum of 10 hours per week early education, either in the local school or in a non-maintained settings.

During term time for 39 weeks, this early education will be part of the childcare offer's 30 hours. During the school holidays, when there is no early education, the offer will

Provide 30 hours a week of childcare, for up to 9 weeks pro rata.

Family Information Service can help to find a registered provider.

A child can access a maximum of two registered childcare settings in addition to their Early Entitlement or FPN setting in any given day.





#### How will parents know if they are eligible?

All parents of 3 and 4 year olds can already access the early education entitlement. For the childcare offer:

- the child must live within a pilot areas
- be within the age range
- the parent must earn on average a weekly minimum equivalent of 16 hours or more at national minimum wage (NMW) or national living wage (NLW) or more.
- One parent family need to be working
- two parent family both need to be working
- self-employed or zero hours contract need to be able to prove this by providing the relevant documents.

(There are a number of Exemptions too)





#### Aims of the pilot / early implementers

To test the offer to make sure it works, eventually to be available across Wales (Ref: Welsh Government Taking Wales Forward 2016 –2021)

In Flintshire, this will allow testing of the Offer in areas of low and high employment, across travel to work routes, including travel outside Wales, and through a mixture of maintained and non-maintained settings. To test papacity and demand of childcare along with how it fits with the Foundation hase and Welsh medium provision.

Close monitoring will provide lessons to adapt the offer accordingly.





#### Can a parent choose any childcare provider?

Yes, as long as they are willing to be part of the Offer and they are registered with CSSIW - Wales or OFSTED - England (the inspectorates for childcare settings).

Races are available. The agreement is between the parent and the Setting.

It is up to parents to find a childcare provider that suits their families' needs – the list of registered settings is available through the on-line application process.

The Family Information Service can help by providing information on all childcare settings.





#### Will a parent have to pay for anything?

It does not include food, transport to and from other settings or off-site activities that incur an extra charge and providers will be able to charge for these.

Providers should not charge more than £7.50 per day for food or £4.75 for half a day (including lunch).

It does not include hours above the Offer, these are paid for by the parent.

#### **EXECUTIVE SUMMARY**

To inform Education and Youth Overview and Scrutiny Committee of the Welsh Government's (WG) Reducing Infants Class Sizes and Raising Standards Grant.

RECOMMENDATIONS		
1	The Education and Youth Overview and Scrutiny Committee is requested to note the contents of the report.	

#### **REPORT DETAILS**

1.00	BACKGROUND AND CONSIDERATIONS
1.01	The Cabinet Secretary for Education, Kirsty Williams AM, announced details of a new £36 million fund to address infant class sizes and raise standards.
1.02	The £36 million (a combination of £16 million revenue and £20 million capital) is being made available nationally over the period 1 April 2017 to 31 March 2021.
1.03	Funding will be targeted at classes with 29 or more pupils. According to WG, International research and evidence shows us that a reduction in class sizes makes the most difference for the youngest pupils and particularly those from poorer and/or minority language backgrounds.

1.04	The WG criteria for the grant funding relates to schools with infants cla sizes of 29 or above, who demonstrate at least one, or a combination, the following:  • significant levels of free school meals; • below average outcomes and where a school is judged to be red			
	<ul> <li>amber;</li> <li>significant levels of special educational and additional learning needs;</li> <li>significant levels of where Welsh/English is not the first language.</li> </ul>			
1.05	The WG has determined that the mechanism for distribution of the revenue element of the grant will be a combination of the Nursery and Primar School Teaching and Other Services Indicator Based Assessment (IBA element of the Standard Spending Assessment and the number of classe of 29 and over in each local authority (using a 4 year average of PLASO data between 2013 and 2016). The grant will be weighted 60% for the SSA element and 40% for the class sizes element.			
1.06	The table below sets out the total amount of the potential revenue of that will be available to the Council from WG for this purpose. Funding across four years 2017/18 to 2020/21. While the figures for 2017-18 firm, the amount of funding available for this fund beyond the cu financial year is indicative and subject to future spending decisions as of the Welsh Government's budget process.

1.07	WG required Councils to submit a business cases for consideration. T business case required LA's to focus on the revenue element of the grawhilst setting out proposals for the capital element of the grant. See Appendix 1 – Business case submission to WG.			
1.08	WG requested that Councils specify the details of how the funding would be used each year for the agreed four year period 2017-21. WG required information on how the funding would impact pupils with free school meals, additional needs, teacher/pupil ratios, performance, attendance and sustainability.			
1.09	The Council's submission to WG proposes to use revenue funding to raise standards in the targeted schools by:			
	<ul> <li>developing Oracy in 2017/18;</li> <li>developing reading and writing in the Foundation Phase in 2018/19;</li> <li>improving performance in maths and numeracy in 2019/20; and</li> <li>improving performance in digital competency in 2020/21.</li> </ul>			

1.10	The revenue grant will enable a review of current practice, demands and impact of class sizes on schools and to consult with Head teachers to look at new and innovative ways of reducing class sizes (whether more general additional class learning spaces are required or focused learning spaces for intervention teaching with groups of learners).
1.11	With £20m capital funding available nationally the Council has submitted a request for £1,820,000 to fund two proposed projects, in priority order as requested by WG. They are as follows:  1. Ysgol Glan Aber, Bagillt 2. Westwood CP, Buckley
1.12	In terms of Ysgol Glan Aber, the school already has a commitment of £997,000 through the Council's Capital Programme. However, the detailed feasibility work recently undertaken has identified a number of suitability/circumstance issues which have resulted in the proposal to enlarge the scope of the original scheme. The proposal to WG, for an additional £1,320,000 in capital would allow the Council to address all the issues identified through detailed feasibility study. The proposed scheme at Westwood CP School (£500,000) would modernise and rationalise facilities at the school into one building.
1.15	Councils are expecting feedback on their submission's from WG during December 2017.

Sustaining progress and further improving outcomes in the Foundation Phase remains a focus in 2017 – 2018 for the Council. In partnership with the regional school improvement service, the local authority is committed to ensuring the highest standards at all key stages and ensuring that all learners make appropriate progress from one key stage to another. Flintshire County Council's Improvement Plan includes as a priority, **Learning Council**: **High Performing Education**. The three relevant objectives are:

- 1. Providing high quality learning opportunities, and learning environments for learners of all ages.
- 2. Supporting children and younger people to achieve their potential.
- 3. Supporting learners from 3 to 18 years of age to aspire to high levels of educational attainment and achievement.

#### This is a priority this year because we need to:

- Utilise resources effectively to achieve the best possible educational outcomes
- Support the national Welsh Government priorities to improve literacy and numeracy outcomes and reduce the impact of poverty on educational attainment
- Work effectively with partners across the region, including GwE, the North Wales school improvement service to secure efficiency and improved outcomes from educational improvement programmes
- Reduce barriers to engagement, ensure equality of access and participation opportunities
- Make more efficient use of education resources through programmes of School Modernisation

Funding to be allocated to each of the 27 schools as additional to the Foundation Phase training grant for 2017 – 2018 delegated to all schools to support access to Foundation Phase Training now that it is being delivered by GwE.

This additional funding (£99,572.01) will enable these schools who meet the above criteria to provide additional small group interventions for developing Oracy and to

access further targeted support and training from the Area Foundation Phase Supporting Improvement Adviser and from the Local Authority Language Advisers. The following activities will be agreed criteria for the additional activity in 2017 - 2018 and schools will be expected to evidence which ones they have accessed and the impact for groups of learners as above, in line with their individual school improvement plans:

- Enhancement / increased provision of additional targeted literacy intervention for learners (focus on developing oracy skills )
- Nursery, reception and year 1 and 2 teachers in targeted schools to plan, resource and implement rich and enhanced oracy tasks. Support and training accessed through the Foundation Phase Supporting Improvement Adviser.
- Attendance at workshops offered by the Foundation Phase Supporting Improvement Adviser to share information and offer guidance on the standardisation of work.
- Access to a two day course, Language Development in the Early Years delivered by Language Advisor and English as An Additional Language Advisor. The training aims to provide early years practitioners with a theoretical understanding of how language develops and the impact of language on learning, behaviour and social and emotional well-being.
- Collaborative activity with a group of Foundation Phase practitioners to produce exemplary FPh profiles of O5 and O6 (to be co-ordinated by the Foundation Phase Supporting Improvement Adviser)
- Collaborative working between targeted schools (with identified border groups 04/05) to ensure sufficient challenge within planning of classroom activities /pedagogy.
- Collaborative working between targeted schools (with identified border groups 05/06) to ensure sufficient challenge within planning of classroom activities /pedagogy.

Following review and evaluation of 2017 – 2018, the grant will focus on further targeted support for:

- Developing reading and writing in the Foundation Phase in 2018 2019 (£149,358.02)
- Improving performance in maths and numeracy in 2019 2020 (£248,930.03)
- Improving performance in digital competency in 2020 2021 (£298,716.04)

The grant will fund a review a review of current practice, demands and impact of class sizes on schools. There will need to be further consultation with Head teachers to look at new and innovative ways of reducing class sizes and in particular to support schools with the increasing demands of meeting the requirements of pupils with additional learning needs. In particular to focus on planning and implementing enhanced opportunities for collaboration / employing teachers and teaching assistants across clusters of maintained schools to meet local needs and support national priorities for improvement as part of a self-improving school system (2018 – 2021).

#### **PRIORITY 1**

#### Which schools are affected?

Ysgol Glan Aber, Y Bwt Sir y Flint, Bagillt CH6 6LW

#### **Current Issues**

Currently the school accommodates Nursery and Reception pupils as two teaching spaces in the hall. The most recent suitability survey, conducted 14/09/16, found that the school is "using the existing layout to its optimum efficiency and only structural changes will address the need to improve classroom layout and size".

The school uses an adjacent youth centre as a hall for P.E. and dining but has no kitchen on site. The survey also confirmed that there is a shortfall in toilet provision whilst

The school has 122 children on roll (Jan. 217) and meals are delivered from the Holywell Learning Campus (1.8 miles approx.), representing the largest delivery of meals across the primary sector. With pupil numbers forecasted to rise to 133 by 2021 the current arrangements are impracticable and would likely lead to significant issues being encountered.

Due to different classroom sizes, every year the classrooms change based on which can accommodate the number of pupils in that particular year group. This obviously causes great disruption to all as the rooms need to support the year group that will be using that room. The school has had to transform the school hall into two classrooms to accommodate the learners whilst using the building next door to the school for lunch time provision. The scheme will have a massive impact on children's learning and on staff well-

being.

There are a high number of pupils on the ALN register and trying to support these learners is difficult due to lack of space. Often they will be seen working in the congested corridors and the Head Teachers office. Giving the children and staff an area dedicated for them would make a difference to their outcomes.

There are also a number of children who need intervention to support their social skills. At present, a small area in the school has been set up to support the well-being of these children. This has been a vital area for our children where they feel they can discuss any issues with a member of staff. Unfortunately, these discussions are often disturbed by other children and staff walking through to get to another area of the school.

#### What is proposed?

The project will address the above issues through a combination of a new build extension and remodelling of the existing facilities. Specifically it is proposed that the adjacent youth club be demolished and a purpose built new hall be erected in its place. The new building also house a purpose built kitchen and servery, a new classroom and storage areas. Extensions to existing classrooms to meet minimum requirements to accommodate 30 pupil places.

#### **Anticipated Costs**

The project is anticipated to cost approximately £2,317,000 with £997,000 having already been secured from the Local Authority's Capital Programme funding.

An Infant Class Sizes Grant of £1,320,000, should it be successful, will allow the project to proceed, considerably improving facilities in the process and positively impacting children attending the school.

It should be noted that approximately £550,000 of costs at basic feasibility stage are associated with risk.

#### Timeframe of spend - outline profile of spend

The project has a provisional start date of April / May 2018 and depending upon the timeline for the approval of the grant the anticipated spend could be:

• 2017/18 - £ 245.000

• 2018/19 - £ 2,031,948 (£1,320,000 of which will be the Grant)

• 2019/20 - £ 40,000 Total - £ 2,316,948

#### How will you procure, if appropriate?

Procurement has already taken place and construction company Kier have been commissioned through a national framework to undertake a feasibility study.

#### Impact on existing policies, including class sizes, surplus places

A better learning environment will help to inspire pupils to learn and will assist the Council in achieving its obligations under the Well-being of Future Generations (Wales) Act 2015. The project promotes a more equal Wales by providing modern facilities which will remove barriers to learning and increase the likelihood of children and young people realising their full potential.

One of the key aims of the School Modernisation Strategy is to improve the quality of school buildings and facilities as it is recognised this is very beneficial to the quality of teaching and morale of staff which in turn positively impacts pupil performance.

Although the proposal will provide more suitably sized classrooms, as well as an additional classroom, they will not increase the current the current capacity of 140 full-time pupils (plus nursery). The number of mixed aged classes will be reduced and the improvements would help to attract more pupils to the school, reducing surplus places from 12.86% currently to 5.0% by 2021.

#### **Expected impact on educational outcomes**

This project will support the school in continuing with its improvement journey, focusing on high quality teaching and learning, and building capacity to move to A for its Capacity to Improve judgement. The school was categorised 2BYellow in 2014, 3BYellow in 2015 and 3BYellow in 2016. Outcomes for the Foundation Phase have fallen over the last three years, with the Foundation Phase indicator moving from 90% in 2012/2013 to 82.4% in 2013/ 2014, 87.5% in 2014/2015, 84.6% in 2015/2016 with a further dip to 78.9% in 2016/ 2017. Outcomes need to move the school to be above the median consistently as the school has been below the median for four of the last four years. (3,3,3,4)

#### Alignment to 21st Century Schools Band B Programme

Projects in the Band B Strategic Outline Programme (SOP) aims to deliver long-term benefits for children throughout their education in Flintshire and provide the best possible opportunity for learners to achieve their potential.

This project complements the SOP by investing in the school and raising the facilities to an excellent standard. Internal learning spaces (classrooms and other areas) will be well proportioned, fit for purpose and meet the needs of the curriculum.

#### **PRIORITY 2**

#### Which schools are affected?

Westwood Primary School, 5 Padeswood Rd N, Buckley CH7 2JL

#### **Current Issues**

The main school building has no area dedicated to nursery provision, which is housed in the adjacent Westwood Centre. This means that nursey children are isolated from the rest of Key Stage 1 pupils and their facilities.

#### What is proposed?

The project will extend and remodel the main building in order to accommodate the nursery provision under one roof and provide continuity throughout the school.

#### **Anticipated Costs**

Firm costs are yet to be determined but it is estimated the project will cost approximately £500.000.

#### Timeframe of spend - outline profile of spend

It is projected that the scheme will require £250,000 funding in 2018/19 and £250,000 funding in 2019/20.

#### How will you procure, if appropriate?

Once anticipated costs have been confirmed, the overall value of the project will determine the procurement method. Options include engaging a contractor under the terms of a pre-existing contract, using a framework or inviting contractors to tender for the works.

#### Impact on existing policies, including class sizes, surplus places

The incorporation of the nursery provision within the main building will enable nursery children to integrate with reception pupils and the rest of Foundation Phase which will help them transition more smoothly from part-time to full-time education, supporting children to be more confident and well-prepared when they move on to the next stage in their learning.

#### **Expected impact on educational outcomes**

This project will support the school in continuing with its improvement journey, focusing on high quality teaching and learning, and building capacity to move to A for its Capacity to Improve judgement. The school was categorised 3CRed in 2014, 3BYellow in 2015 and 2BYellow in 2016. Outcomes for the Foundation Phase have improved over the last four years, with the Foundation Phase indicator improving from 68.4% in 2012/2013 to 74.2% in 2013/ 2014, 81.5% in 2014/2015, 84.6% in 2015/2016 with a dip to 77.8% in 2016/ 2017. Outcomes need to move the school to be above the median consistently as the school has been below the median for three of the last four years despite this improvement. (4,3,2,3)

#### **EXECUTIVE SUMMARY**

The Council Plan 2017/23 was adopted by the Council in September 2017. This report presents the mid-year monitoring of progress for the Council Plan priority 'Learning Council' relevant to the Education & Youth Overview & Scrutiny Committee.

Flintshire is a high performing Council as evidenced in previous Council (Improvement) Plan monitoring reports as well as in the Council's Annual Performance Reports. This first monitoring report for the 2017/18 Council Plan is a positive report, with 88% of activities being assessed as making good progress, and 67% likely to achieve the desired outcome. In addition, 65% of the performance indicators met or exceeded target. Risks are also being successfully managed with the majority being assessed as moderate (67%) or minor (8%).

This report is an exception based report and therefore detail focuses on the areas of under-performance.

#### Recommendations

That the Committee consider the Council Plan 2017/18 mid-year monitoring report to monitor under performance and request further information as appropriate.

## Priority: Learning Council Risk: Sustainability of funding streams.

The sustainability of grant funding remains a major risk. The Council has received within the last week, without prior intelligence from Welsh Government (WG), notification of an 11% cut to the Education Improvement Grant, resulting in a real term reduction of approximately quarter of a million pounds. This grant funds a range of posts within schools e.g. Foundation Phase Support Staff and central service delivery within the portfolio. There is very limited guidance available at the current time from WG to be able to strategically plan for the implementation of this cut. Additionally, other grants e.g. Small and Rural School grant which was made available this year do not appear on the grant schedule for 2018/19. The School Uniform Grant for year 7 pupils entitled to Free School Meals has also been withdrawn without prior notification, leaving a potential cost pressure for the Council or schools to absorb.

# Risk: Numbers of school places not matching the changing demographics.

Reducing unfilled school places via school organisation change is an ongoing process. School change projects can take between three and five years from

inception to delivery before reductions of unfilled places can be realised. This continues to be an ongoing process linked to the school modernisation programme. To supplement this the Council will continue to work closely with schools to consider innovative ways for reduction in capacity on a school by school basis (i.e. alternative use of school facilities by other groups) with the objective of meeting national targets of circa 10% unfilled places in all school sectors.

## Risk: Limited funding to address the backlog of known repair and maintenance works in Education & Youth assets.

Continuation of the School Modernisation programme is one of the strategic options available to address the repair and maintenance backlog. The programme continuation will also i) Support a reduction of unfilled places ii) Provide a more efficient school estate and concentrate resources on teaching by removal of unwanted fixed costs in infrastructure and leadership iii) Ensure that the condition and suitability of the school estate is improved. Additionally, future capital business cases will be submitted through the Council process to supplement the 21st Century Schools investment programme.



#### **ACTION PROGRESS COMMENTS:**

The Service is continuing to work in partnership with the Regional School Improvement Service (GwE) to provide support and challenge to all schools to achieve the best possible educational outcomes for all learners. The Interim Senior Manager for School Improvement (seconded from GwE) has worked closely with the Flintshire Core Leads for Primary, Special and Secondary schools to identify and target support for those schools most in need. Level 2 Business Plans for 2017 -2018 for both primary and secondary school phases are in place. Key priorities are focused around Standards, Curriculum and Assessment, Leadership, Wellbeing and Teaching. Each primary school currently categorised as Amber for support has an appropriate support plan in place and all secondary schools have a support plan in place in line with the revised regional strategy for supporting secondary schools. The Interim Senior Manager for School Improvement has met on a fortnightly basis with the GwE Core Leads for Primary and Secondary in Flintshire to review support for schools and progress against the Level 2 Business Plans. These feed into the Regional Quality Board (RQB) the first meeting has taken place in October as scheduled. Verified outcomes for Flintshire learners at Foundation Phase, Key Stage (KS)2 and KS3 and provisional outcomes at KS4 and KS5 were presented to the Education and Youth OSC on October 5th. Schools across the Local Authority have access this year to an increased professional development offer through the Regional School Improvement Service, including for leadership development, preparation or the digital competency framework and for developing literacy and numeracy. The Welsh Education Strategic Plan Forum has met to review the WESP in light of feedback from WG. The Forum has agreed to establish sub groups to progress key actions and these are currently being put in place. An initial meeting has taken place with the Regional Lead for Developing the Digital Competency Framework in order to audit schools' readiness and cap

#### **ACTION PROGRESS COMMENTS:**

A Skills Summit was hosted by the North Wales Economic Ambitions Board (NWEAB) in September 2017. Work had been undertaken on a regional basis to identify the areas of need and the perceived gaps in employability skills such as digital competency and communication skills. The information from the Summit has been shared with all Flintshire secondary Headteachers to ensure shared awareness of the areas of need. The Welsh Government has developed a Digital Competency Framework (DCF) to support a national improvement in this area. This defines the standards that pupils are expected to meet through their education. Flintshire officers have developed a local response to the DCF and are working in collaboration with GwE, the regional school improvement service to ensure that an appropriate range of training and support is offered to school-based staff to facilitate delivery of the

Framework requirements. A secondary phase working group has been established to support improved outcomes for more able and talented pupils. The group has focused on skill development and offered a number of sessions to support the improvement and development of areas such as communication skills. A suite of vocational options has been offered to KS4 pupils across Flintshire schools. These are delivered through Coleg Cambria and other local work-based providers and offer accredited courses in areas such as Construction, Hair and Beauty, Animal Care, Motor Vehicle Maintenance along with qualifications in Teamwork and Personal Development in the Community and Employability Skills.

#### **ACTION PROGRESS COMMENTS:**

For 2016/17 we set out to achieve Welsh Government (WG) Funding to enable the Council to re-commission a full Families First Programme. The funding (approx £1.6 million) is now achieved. The Council have implemented the new guidance proposals to de-commission elements of the programme which are no longer viable which is now completed. We are now developing a competitive dialogue process. The third sector has been key to delivery and is engaged in all development and all provision. Flintshire County Council procurement service are also supporting the full re-commissioning process. Following the WG agreed transition time, the full programme is now on track for being commissioned for delivery with effect from April 2018. This is on track to be delivered fully and within the financial envelope. The programme has ensured that the new provision is a resource for the Early Help Hub, which is an innovative multi-agency approach to deliver on the Well-being Act. The Families First programme also feeds in to the Well-being Act requirements. The commissioning progress is on track as firm guidance from WG has now been received and the Council are complying with the guidance to move towards delivery phase in April 2018.

#### **EXECUTIVE SUMMARY**

Being online is increasingly part of children and young people's lives as they grow up in the world of technology and social media. Schools have a responsibility to equip children and young people with the skills to be able to think critically and navigate the digital world, in a safe and responsible way.

Although there are many benefits of the internet, it can also place children and young people at risk. The local authority has a duty to safeguard all children and young people which is supported by a three tiered approach to online safety at a national, regional and local level. An overview of the approach taken is summarised in this report for the Education and Youth Overview and Scrutiny Committee.

This report has been produced in response to members seeking reassurance that children and young people in Flintshire schools are receiving the appropriate support to develop their skills in relation to the use of social media and internet safety.

RECO	MMENDATIONS
1	That members receive the report on social media and internet safety and confirm they have received an appropriate level of assurance about the support being provided to children and young people to keep themselves safe.
2	That members acknowledge the support for schools in the ongoing development of the Digital Competence Framework (DCF) and utilising the 360 Degree Safe Cymru tool.

## REPORT DETAILS

1.00	EXPLAINING THE E-SAFETY SUPPORT AVAILABLE TO SCHOOLS
1.01	Context Electronic communications encompass internet technologies which include: the world wide web, chat rooms, E-mail, instant messaging, blogs, and social sites. Digital photography, video and sound recording can also be captured. Mobile phones provide similar functions through texting, taking and sending photos and video clips, which also apply to tablet devices. All of these technologies make a positive contribution to the world and education, but all are equally capable of being misused.
	The Welsh Government's National Survey for Wales: Online safety for Children 2014-2015 (published March 2017) found:
	<ul> <li>95% of children aged 7 to 15 used the internet at home.</li> <li>The device most commonly used by these children was a tablet (71%).</li> <li>64% of children aged 7 to 15, who access the internet outside school, accessed a school learning platform and 67% used the internet to find other information related to schoolwork.</li> <li>87% of parents felt that their child knew how to stay safe when using the internet.</li> <li>56% of households with children aged 7-15 used parental control filters.</li> <li>Further analysis showed that the parents are more likely to use a parental control filter if they are more highly educated, if they also use the internet themselves, if they have more children and if their children are younger.</li> </ul>
	The NSPCC have recently published the Net Aware Report 2017 (September 2017) which explores how young people navigate opportunities and risks in their online lives. They consulted children and young people aged 11-18 years about their online experience.
	Findings demonstrated that young people value opportunities for fun and enjoyment online which includes sharing videos, posting photos and playing games. Social opportunities provided by the internet include keeping in touch with friends and family, school work and building social groups. Young people feel empowered when sites offer effective tools to keep them safe online and praise robust privacy settings and effective reporting / blocking mechanisms.
	However, these positive experiences are often tainted by negative ones. 25% of young people consulted as part of the survey stated that the platform being reviewed was risky. This was across all sites included in the research.
	The primary risks identified by young people were: interaction with strangers, inappropriate content, violence and hatred, sexual content and bullying:

- 30% of young people's reviews reported seeing violent and hateful content. This may be in user-generated content, footage from the news or fictional violence in games.
- 20% of young people's reviews reported seeing sexual content including accidentally finding it, being sent sexual messages or being encouraged to share sexual content themselves.
- 19% of young people's reviews reported seeing bullying. Some noted bullying within a social group while others indicated that the opportunity to be anonymous on some platforms was facilitating bullying behaviour.

#### 1.02 **National Developments**

#### **Welsh Government:**

As the lead organisation for online safety in Wales, the Welsh Government is responsible for promoting the safe and positive use of technology for children, young people, parents and teachers. The Welsh Government encourages schools to make full use of social technologies to improve learning outcomes, while also supporting learners to engage safely and participate responsibly online.

In April 2014, the South West Grid for Learning (SWGfL) were commissioned by the Welsh Government to establish an extensive online safety education and awareness programme across Wales. Online safety practice in education has been strengthened over the last three years by:

#### 1. 360 Degree Safe Cymru

In October 2014, 360 Degree Safe Cymru, an e-safety self-review tool, was launched. This allows schools to review their e-safety policies and practices against national standards and gives practical suggestions to improve and enhance online safety. It provides template polices, in addition to links to good practice guidance and allows schools to identify areas of strength and weakness and benchmark their progress and improvement against other schools. 85% of all schools in Wales have since taken up the 360 degree Safe Cymru tool. An increase in take-up of the tool has been seen from 196 schools in 2014 to 1,375 in 2017.

Schools' use of this tool is monitored at a regional level and nationally. In Flintshire (August 2017) there were 61 schools (78%) registered with the 360 degree safe Cymru tool and of those, 52 had used the tool within the last 12 months. See Appendix 1 for details of usage.

Schools that are able to demonstrate good practice in their Online Safety policy and procedures can apply for the **Online Safety Mark** upon completion of all 28 aspects of the tool. There is a charge for the assessment (£650-£1000 per school based on pupil numbers) and it is required to be reassessed every three years. Successful schools receive an Online Safety Mark wall plaque, certificate and use of the logo. There is currently one school in Flintshire that have been awarded the Online Safety Mark – Cornist Park Primary School, however 22 schools (36%) have completed the 28 aspects of the tool.

#### 2. Online Safety Zone on Hwb

The Online Safety Zone on Hwb provides a digital learning platform for schools in Wales that can be accessed by teachers, parents and learners. The dedicated area hosts news, articles and a range of resources on various online safety issues to help keep learners safe, which includes case studies, guidance for school professionals, tips for parents and young people and resources on the safe use of social media sites like Facebook, Snapchat, Instagram and Twitter. It also signposts those dealing with the effects of online bullying or any online safety issues towards appropriate support services.

A series of playlists have also been developed which focus on digital literacy topics such as online reputation, images and identity, copyright, relationships and sexting. Each topic includes a playlist for primary and secondary schools, an introductory playlist for teachers and a resource for parents.

Over the past year there has been a significant increase in the numbers of teachers and learners visiting the Hwb platform. Figures from January 2017 demonstrate that there were over 2.6 million page views and over 670,000 log-ins to the platform – this equates to over 21,000 log-ins per day.

#### 3. Online Safety Resource for Wales

The Online Safety Resource for Wales is a programme of 5 lessons and supporting materials for all ages (Foundation Phase - Key stage 4) which develop essential digital literacy skills in learners that can be integrated within the existing school curriculum with flexibility. The Online Safety Resource is designed to empower learners to think critically, behave safely, and participate responsibly in our digital world. The free materials are based on Common Sense Media resources from the United States and the planning provides further opportunities to extend learning.

#### 4. Online Safety Training

Online safety training sessions have been delivered across all 22 local authorities by SWGfL, training approximately 2,300 professionals. Training has aimed to raise awareness of e-Safety issues and promote 360 degree safe Cymru and the Online safety Resource to teachers, governors and local authority teams.

GwE has a digital training programme with termly events throughout the region for primary and secondary school staff. This includes online safety training for Newly Qualified Teachers (NQT's) from primary and secondary schools in Flintshire, as part of their induction on October 6<sup>th</sup> 2017.

Training on 'using social media and its impact on schools' was held on 25th October 2017 in Flintshire coordinated by Governors Wales. There were 23 governors in attendance.

SWGfL have recently provided a series of workshops across Wales for Designated Safeguarding Leads in schools with a focus on online safety. Both the Interim Chief Officer for Education and Youth and the Operational Page 72

Safeguarding Lead Officer have also attended.

### 5. Safer Internet Day

Safer Internet Day is a global awareness day to promote good practice in online safety and gives advice and guidance on the risks posed by new technologies such as social media and how to stay safe while using them.

The day offers us the opportunity to raise awareness of what is being done in Wales to safeguard learners online and highlight responsible use of technology in schools, colleges and the home.

Bilingual Safer Internet Day education packs for teachers with resources to help schools celebrate Safer Internet Day have been developed and made available on Hwb for the annual event in 2016 and 2017. The next Safer Internet day will take place on Tuesday 6<sup>th</sup> February 2018.

## 6. Digital Competence Framework

In September 2016 the Digital Competence Framework (DCF) was published, the first element of the new curriculum to be made available across Wales. Digital competence is the set of skills, knowledge and attitudes that enable the confident, creative and critical use of technologies and systems. It is essential for learners if they are to be informed, capable and have the potential to be successful in today's society.

The DCF sets out the digital skills to be attained by learners aged between 3 and 16-plus across four strands: Citizenship, Interacting and collaborating, Producing, Data and computational thinking.

The Citizenship Strand focuses on developing and applying critical thinking skills and strategies. It includes specific elements focused on online behaviour, cyberbullying together with health and well-being.

For each element there are skill statements which describe the skills a learner would be expected to have attained at a given stage. To help clarify their meaning and purpose, skill statements are supported by examples of 'classroom task ideas' that could be used to demonstrate competence for a particular skill.

Training and support for implementing the new curriculum is being led by the Pioneer Network, working with the regional consortia. The timetable for implementation is as follows:

From September 2016 - Developing understanding and planning From September 2017 - Refining and integrating the DCF into the new curriculum

From September 2018 - Emerging new curriculum with digital expectations embedded

In the interim, where schools are creative and imaginative in taking forward initiatives for the benefit of learners, including drawing on the DCF to develop

their practice, Estyn inspectors are approaching such innovation in a positive way.

### 7. National Online Safety Action Plan

A national online safety action plan for children and young people is currently in development and will provide a strategic overview of how the Welsh Government will continue to enhance online safety support in Wales.

#### 8. Guidance

The UK Council for Child Internet Safety (UKCCIS) developed 'Sexting in schools and colleges: Responding to incidents and safeguarding young people' Guidance in September 2016. This has since been updated in 2017 and cascaded to all schools in Flintshire in October 2017. Welsh Government are yet to release guidance for Wales, although this is in development.

The Guidance aims to support schools in developing safeguarding procedures to respond to incidents involving youth produced sexual imagery. It highlights key sources of resources and support that will help schools when incidents take place.

This guidance was produced following an NSPCC study in 2016 which found that 7% of 11-16 year olds had sent a sexual image to someone else. Although most young people are not creating or sharing this type of imagery, the potential risks are significant and there is considerable concern about the issue in schools and amongst parents.

With that in mind the guidance includes:

- How to respond to incidents
- The appropriate way to handle devices and imagery
- Effectively assessing risk
- When to involve other agencies
- How to record incidents
- Whether and when you should involve parents or carers
- Strategies to prevent such incidents from occurring.

#### 9. Education Workforce Council (EWC)

Staff have an influential position in all schools and should act as role models for pupils by consistently demonstrating high standards of behaviour.

Expectations for teachers' professional conduct are set out by the Education Workforce Council (EWC) for Wales with all teachers required to act in accordance with the personal and professional behaviours set out in the Teachers' Standards. Adults working with children and young people should understand that the nature and responsibilities of their work place them in a position of trust and that their conduct should reflect this.

The EWC highlight that teachers should:

'ensure that any communication with learners is appropriate, including communication via electronic media, such as e-mail, texting and social Page 74

networking websites;

Staff members who harass, cyberbully, discriminate on the grounds of sex, race or disability or who defame a third party may render the school or local authority liable to the injured party. Reasonable steps to prevent predictable harm must be in place.

A workshop for head teachers has been held in Flintshire on September 21<sup>st</sup> 2017 delivered by EWC, with input from the Council's Human Resources department. The workshop was very well attended and received positive feedback.

## 1.03 Regional Developments

## The Regional School Improvement service (GwE):

Within the successful futures team at GwE there is a lead advisor for the DCF remit supporting all phases and all schools in the region.

Across North Wales there are 4 Digital Leaders in post since September 2016. They were seconded from schools to provide support for the DCF and HWB. Two of the Digital Leaders come from Flintshire schools:

- Kellie Williams (Cornist Park School, also a Digital Pioneer School)
- Alex Clewett (Flint High School, former Digital Leader WG)

The Digital Leaders work with the regional DCF Network group in the delivery of a wide range of DCF related activities across the region and sub-regional hubs. The Digital Leaders mainly work in schools with teachers, pupils, schools leaders and teaching assistants, to raise standards of teaching and learning through effective use of Digital Technologies, in addition to supporting the "Pioneer Schools" initiative across the region within the context of Digital Competence. Increasing the number of schools actively engaged with the 360 Degree Safe Cymru e-Safety Framework is also identified within their remit.

GwE have established Lead Online Safety schools across the region that are receiving support this academic year (17-18) to enable them to complete the 360 Degree Safe tool and apply for assessment Quality Mark. In Flintshire, Southdown Primary School are the lead online safety school.

## 1.04 Flintshire Developments

### IT Infrastructure Services (Corporate Services):

The requirement to ensure that children and young people are able to use the internet and related communications technologies appropriately and safely is addressed as part of the wider duty of care to which all who work in schools are bound.

Following discussion and consultation with schools, Library and Youth services, the county's approach to Internet filtering was changed in February

2016 from being risk averse, to a risk managed approach. Pupils were given the skills and strategies to help keep themselves stay safe online and develop into responsible digital citizens.

This was in line with developments initiated by the Welsh Government and the basis of our Internet filtering will be implementation of the Welsh Government age-related standards for web filtering. The filtering policies are reviewed regularly in line with national guidance. Welsh Government have recently began a review of their standards. Schools have the ability to modify the filtering standards for their own school (and have done so) and accept any risk in doing so.

Alongside the new internet filtering technology developments, in April 2016 the following were reviewed:

- Internet filtering policy (to reflect the Welsh Government Standards for Internet Filtering)
- Schools Acceptable Use Statement

And the development of a:

 Policy for the Maintenance of a Suitable Environment for use of Electronic Communications.

An **Acceptable Use Policy** identifies constraints and practices that a school will adopt, review and maintain to ensure all members of the school community are able to use the Internet and related communications technologies appropriately and safely. The Acceptable Use Policy should be seen in a whole school context and be linked with other relevant policies such as the Safeguarding, Behaviour and Anti-Bullying policies.

Due to the ever changing nature of digital technologies, it is best practice that the school reviews its policy at least annually and, if necessary, more frequently in response to any significant new developments in the use of the technologies, new threats to e-safety or incidents that have taken place.

An **Acceptable Use Statement** is a summative declaration of a school's commitment to ensure all users of its ICT systems are able to use the Internet and related communications technologies appropriately and safely. It is an overarching commitment that identifies key expectations within the provision that a school will make to provide an e-safe environment. This commitment is recognised formally through the signatures of the Head teacher and Chair of Governors.

Schools were required to submit signed Acceptable Use Statements to Flintshire IT Infrastructure Manager, by the end of the summer term 2016.

1.05 Schools participating the Welsh Network of Healthy Schools Schemes (WNHSS) working towards the National Quality Award are required to develop and evidence a whole school approach towards seven health themes, one of those is safety (which includes e Safety).

The national Healthy Schools criteria addresses: policy, training, participation in local and national initiatives, curriculum delivery, pupil voice,

the environment, parent engagement and working with outside agencies.

Among the local initiatives which are recognised as part of the scheme is eCadets, which provides peer-peer education for pupils and the school community about e Safety, delivered via training and interactive challenges through the website. There are 39 schools in Flintshire that currently participate in this initiative (November 2017).

The All Wales School Liaison Core Programme (Police) also provides a valuable contribution to Curriculum delivery (as part of Personal and Social Education) in all primary and secondary schools. The Police School Liaison Officer provides support for schools in addressing online safety issues relating to social media.

2.00	RESOURCE IMPLICATIONS
2.01	The provision for support for schools comes predominately through the regional school improvement service, GwE and through free online resources via the Hwb.
2.02	The potential barrier to schools undertaking the Online Safety Mark is the cost involved (£650-£1000 per school based on pupil numbers), in particular when there is also a cost for the reassessment every three years.

3.00	CONSULTATIONS REQUIRED / CARRIED OUT
3.01	Extensive consultation has been undertaken at a national and regional level in this field.

4.00	RISK MANAGEMENT
4.00	NON III/ NO COLINEIN
4.01	Risk for Pupils  If precautions are not taken, these technologies can expose pupils to hostile individuals, including sexual predators, who can form relationships with pupils, sometimes using false identities or posing as a child. This is known as grooming. The technologies can expose pupils to pornography and pornographers, to materials extolling violence, drugs or prejudice hatred. The technologies can also enable bullying. This risk is mitigated against by schools involving pupils in a development programme of training and support suitable for their age through a range of different opportunities and also by providing information and support for parents.
4.02	Risk for School Staff  The school environment can provide some adults with the opportunity to exploit technologies for their own inappropriate purposes unless appropriate safeguarding measures are in place. These include downloading or publishing offensive or illegal materials and initiating improper contacts with young people. Staff are also vulnerable if they are singly responsible for the

	administration of passwords and filtering. This is mitigated against by having clear policies and procedures within schools that are monitored regularly and by having regular training for staff.
4.03	Risks for Local Authorities The risk for Local Authorities is the potential to breach statutory legislation related to safeguarding and the welfare of children e.g. The Children Act (2004) All Wales Child Protection Procedures (2008) The Rights of Children and Young Persons (Wales) Measure 2011 School Standards and Organisation (Wales) Act 2013 The Prevent Duty – Counter Terrorism & Security Act (2015)
	There is also potential for reputational damage and negative press coverage if there are significant breaches of policy involving pupils or staff in relation to internet or social media activity.  This is mitigated by the Council having named officers with specific
	responsibilities for safeguarding who co-ordinate the dissemination of information to schools, organise training for staff and governors, produce model policies for schools to adopt and monitor the implementation of those policies. The Council also provides firewall and web filtering services to schools via a service level agreement.


