Workload increases have already been evident in relation to Isolation Payments and tenancy Hardship Grant.

The additional work in relation to the removal of the UC uplift will likely be around supporting residents with budgeting or money advice and supporting with access to DHP or Tenancy Hardship Grant.

As the income customers are receiving from UC will decrease, this may result in a small increase in CTRS for current customers. In some cases, where customers UC was slightly too high to qualify for CTRS, they may now qualify. However, both scenarios will increase CTRS expenditure and may put further financial pressure on FCC budgets to meet the increase in the cost of the CTRS scheme. At present we don't have a list of affected customers so are unable to accurately forecast either scenario.
