**1.00**   **PURPOSE OF REPORT**

1.01    To request that Members determine an application for the review of the club premises certificate at Coed Llai Sports and Social Club, King Street, Leeswood.

**2.00**   **BACKGROUND**

2.01    An application for a review of a club premises certificate at Coed Llai Sports and Social Club, Leeswood, was received by the Licensing Section on 18<sup>th</sup> April, 2013. The application was made by the Licensing Authority acting as a Responsible Authority on the grounds of the prevention of crime and disorder, the prevention of public nuisance and the protection of children from harm.

2.02    A number of issues relating to the running of the Coed Llai Sports and Social Club gave rise to concerns that it may not be satisfying the requirements laid down in the Licensing Act 2003 in respect of qualifying clubs. These are specified in the review application.

2.03    The Licensing Authority attempted to seek information from the club that would enable it to determine whether the club was established and conducted in good faith in accordance with Part 4 of the Licensing Act 2003. A written request for information about the governance of the club was not responded to and repeated attempts to set up meetings to discuss matters proved unsuccessful.

2.04    The review application plus supporting documents are shown in the appendices to this report.
