## **REVIEW APPLICATION – COED LLAI SPORTS AND SOCIAL CLUB**

I write with reference to an application for the review of Club Premises Certificate – CA0015 - Coed Llai Sports and Social Club, King Street, Leeswood, Flintshire. CH7 4RU

North Wales Police wish to make the following representations:-

North Wales Police support the grounds for review, put forward by Flintshire County Council and consider that poor management of the premises is the most significant factor resulting in the recurring concerns at this premise.

There have been a number of issues related to the running of the club that have given rise for concern, which are outlined in the review application and evidenced by supporting documentation.

North Wales Police, Local Authority and the Gambling Commission believed a stepped approach to engage with representatives of the club, reference the Licensed Premises Review Procedure, (copy attached) to be a fair and effective way in addressing concerns at this premise.

Unfortunately, despite efforts to arrange to meet, representatives failed to attend our scheduled meetings, resulting in this application for a Review of the Club Premises Certificate.

Since the submission of this review application, a further incident has been reported to North Wales Police. Police Reference Event P073179 refers. This incident occurred at 19.58 hours on 11<sup>th</sup> May, 2013, whereby a person identifying himself as the Chairman of the Coed Llai Club has contacted North Wales Police reporting that his bar staff have contacted him stating that there are two males and a female at the location kicking off. A further call is made to North Wales Police and it is established that


