OF A PREMISES LICENCE – MAES BODLONFA,
KENDRICK’S FIELD & ORNAMENTAL GARDENS,
MOLD

1.00 PURPOSE OF REPORT

1.01 To request that Members consider and determine an application for a review of the premises licence at Maes Bodlonfa, Kendrick’s Field and Ornamental Gardens, Mold.

2.00 BACKGROUND

2.01 Mr Glyn Holywell who resides in the immediate vicinity of Maes Bodlonfa, Kendrick’s Field and the Ornamental Gardens has applied for a review of the premises licence at this location. The application is made on the grounds that the applicant does not feel the Licensing Objective of ‘the prevention of public nuisance’ was being met.

3.00 CONSIDERATIONS

3.01 The complete review application which was submitted by Mr Holywell on 12th January 2015 is shown as Appendix A

3.02 The review process must be advertised by the Authority in order to allow persons to make representations if they wish to do so as interested parties. The application was advertised by way of blue notice on the premises, in the reception areas of County Hall and on Flintshire County Council’s website as required by the Licensing Act 2003
