## 1.00 PURPOSE OF REPORT

1.01 To advise the committee of its terms of reference

## 2.00 BACKGROUND

- 2.01 At the 2014 Annual Meeting, it was agreed that a review of the Overview & Scrutiny should be carried out. Following a series of meetings and the setting up of a working group, the Constitution Committee at its meeting on 15<sup>th</sup> April approved a new structure and terms of reference for the Overview & Scrutiny committees.
- 2.01 The recommendations following the Overview & Scrutiny structure review were submitted to Council at the Annual meeting on 12<sup>th</sup> May 2015.

## 3.00 CONSIDERATIONS

- 3.01 The terms of reference are attached as appendix 1.
- 3.02 There are two major differences between the new terms of reference and the old. Scrutiny responsibility for Revenues and Benefits is now within the remit of the Community & Enterprise Overview & Scrutiny Committee Corporate Resources is now the designated 'crime and disorder' scrutiny committee. This function was previously with the former Community Profile & Partnerships Overview & Scrutiny Committee.
- 3.03 The Crime & Disorder Act 1998 and the Crime & Disorder (Overview & Scrutiny) Regulations 2009 require the Council to designate one of its Overview & scrutiny committees as its statutory crime & disorder scrutiny committee. That committee must meet at least once in a twelve months period to consider crime & disorder issues. This can be achieved by consideration of the Annual Community Safety Partnership Update.
